Trump, Stephen Miller, and Kash Patel are using a dangerous national security memo called NSPM-7 to attack people who speak out against the White House.¹ Masked government agents are already arresting people at anti-ICE protests and for social media posts about “Antifa.”²

NSPM-7 directs the full powers of the Trump administration to investigate people who hold so-called “extreme” beliefs on gender, race, or immigration, or have political views that the White House labels as "anti-capitalism," "anti-Christianity," or "anti-Americanism."³

The memo aims to label opposition to Trump’s policies as **“domestic terrorism.”** **Trump’s thugs are weaponizing the federal government to silence dissent.**

It’s unconstitutional. It’s dangerous. It shows that the Trump regime is willing to persecute anyone who criticizes its authoritarian policies — whether at an ICE protest, a No Kings rally, or while expressing left-of-center political views online.

Trump's loyalists are even creating a new domestic terror "watchlist" as part of NSPM-7.⁴ The ACLU called the memo a "fever dream of conspiracies."⁵ It's an **all-out push to criminalize speech and throw dissenters in prison.**

Rep. Ro Khanna made the stakes clear, calling NSPM-7 a "greater infringement on freedoms than the Patriot Act."⁶

Trump, Patel, Miller, Pam Bondi, Kristi Noem, Tom Homan and the rest of this far-right regime are trying to strike fear into every activist, person of conscience, and organization opposing its drive towards full-blown authoritarianism.
